

A G R E E M E N T

An agreement made this 26TH day of MARCH 1985
between SOE MALINGA FERR AND ON BEHALF OF BRENDA
AND THE BIG DUDS

(hereinafter referred to as the PROMOTER) of the first part,
and LINDA BERNHARDT FERR AND ON BEHALF
OF UNITED DEMOCRATIC FRONT
(hereinafter referred to as the ARTIST/ARTISTS) of the second part.

1. The PROMOTER engages the ARTIST / ARTISTS to appear at FUN VALLEY
on SUN 28TH APRIL 1985

2. The ARTIST/ARTISTS will perform for ± 45 MINUTES

3. The remuneration for the ARTIST/ARTISTS shall be R6000-00

(5.4 THOUSAND RAND ONLY) R500-00
which amount shall be secured in cash or any approved guarantee to be R2500 00 ON SIGNING
furnished by the PROMOTER at the rate of 50 % of the total amount R2000-00 WEEK
as a non refundable deposit and balance of payment to be made to SOE MALINGA BEFORE
AT THE SHOW

4. The PROMOTER undertakes to provide return transport to and
from for the ARTIST/ARTISTS and all their
equipment. OR the PROMOTER undertakes to pay the full costs of the
transport for the ARTIST/ARTISTS and their equipment to and from

5. The PROMOTER undertakes to provide hotel accomodation and three
meals a day for the ARTIST/ARTISTS. OR the PROMOTER undertakes to pay
the costs of accomodation and three meals per day for the ARTIST/
ARTISTS from the time of their arrival in up to
and including

6. The ARTIST/ARTISTS having read the following conditions relating to this agreement and acknowledge that :-
- a. HE/HEY will present HIMSELF/THEMSELVES at the venue on hour prior to the time that HE/THEY are scheduled to appear together with all necessary band equipment.
 - b. HE/THEY will present HIMSELF/THEMSELVES at the venue in a sober state.
 - c. The ARTIST/ARTISTS will be on stage promptly when called upon to do by the M.C. or representative of the PROMOTER.
7. The PROMOTER undertakes to provide a full professional sound system for an outdoor/indoor show with all the necessary amplifiers, speakers, mixers and microphones. Or as specified below.

Notwithstanding the place of signature of the Agreement the same shall be interpreted according to the law of the Republic of South Africa. In the event of any dispute arising out of this contract between the PROMOTER and the ARTIST/ARTISTS the Magistrate's Court of South Africa shall have the sole jurisdiction to the exclusion of any other court.
