This is not a complete report on what took place at the N.E.C. The reason being that some of our documents were seized by policemen in Alice before a full report could be made.

The meeting was scheduled to start at 9.00a.m. Friday 12th, October, 1973, but because of late arrivals we had to start at 2p.m. same day.

OPENING: The meeting was 'opened by the Vice-President of SASO Rev. H.L. Qambela " at 2p.m. same day. He briefly outlined the nature of the meeting, delivered a short speech on the recent spate of indiscriminate bannings.

REPORTS:

(a) Head Office:

A verbal Head Office report was presented by Pumzilee. It was a short report in view of the fact that I had just assumed duties

at Head Office. There was no other report from Head Office. This is so because the people who were at Office before I came had been recently banned.

(b) Regional Secretaries:

.(i) Western Cape: There was no report tendered, and Council imagined that this was so because Mr Issel had just been banned. However, we are still awaiting some report from our Western Cape Regional officer.

(ii) Eastern Cape:

The Eastern Cape report covers the following projects:

- (i) Probeat
- (ii) Literacy
- (iii)Culcom
-)iv) Black Workers .
- (v) Eduploy

<u>Probeat:</u> As probeat function was organised in P.E. after G.S.C. It was to be staged at Alabama Hotel. The system interferred by intimidating the Hotel Manager with the result that the function could not go on.

Literacy: There is a group of people who have been trained but presently the number is very low because many people have left the Eastern Cape e.g. Fort Hare Students. Presently is planning to embark on literacy work at Diml 22a.

Culcom: Dashiki staged about 5 shows in the Eastern Cape and they had a terrific impact in promoting Black art, culture etc..

<u>Black Workers</u>: preliminary contacts have been established but there isn't much work which has been done so far.

Edubloy: In this regard, one finds problems because of lack of jobs. In the report it is suggested that even students who get jobs on their own should be approached in order that they can provide information about working conditions.

(iii) Transvaal:

The report covers the vist by the Regional Secretary and Welile to the Mafso SACC Local branch. The local branch members explained to them the problems they encounter plus their future plans. During the meeting the branch members

resorted that the Black consciousness movement has been received with acclaim by the people. They also visited Rooigrond to look into possibilities of starting a project there. Rooigrond is a resettlement area. People in this area are generally poor, there are no schools and people are dying daily of hunger and diseases. They realised that there is need to help the people in this area by establishing soup-kitchens providing health services, but at the same time make it a point that you dont inculcate a dependency complex. In the last N.E.C. a resolution was passed to the effect that a community development project be stated in this area.

Black Workers:

Not much done here because Wellle had to assist the Transvaal Regional Secretary until he could take care of the situation on his own.

Break: for tea at 4.20 p.m. Resumed: 4.30 p.m.

Brach and Centre Reports:

Centres who gave reports were:

The meeting strongly reprimanded the Preso Branch for having shown a definite lack of activity and initiative. Other branches were warned in a similar fashion, because the Council felt it is pointless keeping passenger, branches as they only frustrate the work of the organisation as a whole.

-STRATEGIES:

Certa n strategies were formulated to take care of the situation as regards bannings and harassment, but for obvious reasons they cannot be disclosed in this report.

CAMPUS VISITS:

Council dealt with this issue quite at length and to resolve a lengthy debate the following mot - 1 was tabled.

Review of Projects:

New areas were defined for the starting of new Projects. In this regard there were three emotions which were tabled and adopted. Unfortunately these motion cannot be found since the Alice cops felt that they need them.

The first motion was for continuing a physical project which had been started by Seminar people in Alice, at Upper Goumushe Locacation.

The second motion was to the effect that a sum of R500 be granted to Mpeko people near Umtata. People in this area are trying to build up a school. It was felt that the area in view of the fact that it is not far from Rev. Qambele's place could be adopted.

The third one is about a place called Rooigrond. This area is near Mafcking and the people have for a number of times been threatened with eviction by the S.A. Government co-operating with Bophutatswana so-called Government. The people in this area live in poor conditions. The Western Cape SASO Local branch was also mandated to look into possibilities of starting a project at a place called Elgin near Cape Town. This is sort of an

. DECENTRALISATION:

Under this topic a motion will suffice.

That this N.E.C. noting:

- (i) the need to restructurise Branch Executive
- (ii) the need for regional Secretaries to determine and define areas of co-operation with branches.

-OTHER MATTERS:

Co-operation between SASO and SRC in campuses was also discussed and it was in fact emphasised. No particular strategies were laid out since this is a situational case.

Amongst other things, it was stated emphatically that students who go for projects should see to it that they dont misbehave. What happen at Dududu during the Dec. holidays antagonised many supporters to the extent that the whole thing almost cost us a project.
