PAUL PRETORIUS: BANNED NO PASSPORT

The 22 year old President of NUSAS for 1972.

Paul was born in Johannesburg and has spent most of his life in Durban where he attended Marist Brothers High School. He matriculated in 1965 with a first class pass and was Dux of his school. He was also a school prefect, a member of the 1st Rugby Team and was voted Best Speaker of the school.

From school he attended the University of Natal in Durban where he graduated Bachelor of Arts in 1969, majoring in Latin and Roman Law. He completed his first LL.B in 1970. In the field of student politics, he was elected to the SRC in 1968 and served a second term as the SRC President in 1969/70. Paul also served on the Rag Committee and Sports Union, as well as being a member of the university 1st Rugby Team. He was elected NUSAS Deputy President in 1970 and served in this position full-time during 1971. He was serving his second term of office when he was banned. During his university course, he has been awarded a number of bursaries and scholarships, and in 1970 won an Abe Bailey Scholarship for a study tour of Europe. Paul is a keen and expert sportsman, and a thoroughly popular student.

PAULA ENSOR: BANNED NO PASSPORT

A brilliant student, Paula matriculated from Girls College in Durban with six distinctions.

She majored in economics and statistics gaining four firsts in her degree and, at the time of her banning, had just completed an honours degree in Economics. She passed with an upper second.

Vice-President of the Durban SRC in her second year, she served two terms as Natal Regional Director on the NUSAS Executive and one as the NUSWEL Deputy Secretary-General.

A talented swimmer, she swam for the Durban schools team and the University team. An immensely dedicated person, she has a keen and critical intelligence which cannot tolerate sham or hypocrisy.

NEVILLE CURTIS BANNED NO PASSPORT

studied for a B.A. at Wits, participating widely in student activities, ranging from serving on Rag Committees to being a member of the Arts Faculty Council. He edited "Wits Student", and served on the SRC, as Deputy Vice-President and the following year, as Vice-President. 1967. he was elected National President of the S.A. National Student Press Association. In 1969, as a post-graduate student, he was elected Deputy Vice-President of NUSAS. This was followed by his election to the NUSAS Presidency, a position which he held for two years in 1970 and 1971. Whilst President, he initiated and directed the reassessment campaign which resulted in an expanded and diversified NUSAS. In 1972, his passport was removed. He organised the 10 days Academic Freedom Protest commemorating the passing of legislation segregating the Universities. In 1973, he was Western Cape Director of the SPROCAS programme and, at the time of his banning, he was studying for a M.A. in African Government.

He attended Jeppe Boys' High School,

matriculating in the first class.

SHEILA LAPINSKY BANNED

Mrs Sheila Lapinsky (nee Barsel). Is the 27 year old General Secretary of NUSAS. Born in Johannesburg, she matriculated from Parktown Girls' High in 1961. From there, she attended the University of the Witwatersrand where she completed her first year B.Sc. before changing to a B.A. course in which she graduated in 1966, majoring in Psychology, Sociology and Afrikaans. While at Wits, she was news editor of'Wits Student' and Chairman of NUSAS Local Committee. She later served as Regional Secretary of NUSAS for the Transvaal, and was on the Executive Committee of WITSCO. Sheila taught at the African Night School in Johannesburg up until the time it was closed by the government. She joined the NUSAS Head Office permanent staff in 1966 as the General Secretary, a position she has held ever since.

CHRIS WOOD BANNED. NO PASSPORT He matriculated, at St.John's College,
Johannesburg, where he was an outstanding
sportsman gaining full colours for rugby.
He went to Wits for two years and then
came to Cape Town and was in his finalyear BA which he will not be able to
complete.

He was editor of the Rag Magazine, Sax Appeal and editor of Varsity. He was vice-president of NUSAS and a keen drama student.

In the report of the Commission of Inquiry, it was stated that in two years Philippe had obtained four subject credits at University. Subsequent to his 1972 year of study, Philippe has eight subject credits.

Clive Keegan attended Bishops School in Cape Town and then went to Rhodes University where he completed his major in Political Science. While at Rhodes University, he edited "Rhodeo", served as Deputy President at the Rhodes S.R.C. and completed two terms as the Eastern Cape Regional Director. He also served on the executive of the National Catholic Federation of Students. He was elected to the position of Aquarius Secretary General in 1971. At the beginning of 1972, he transferred to U.C.T. to complete his degree. At the time of his banning, he was editor of

time of his banning, he was editor of 'Varsity' for the second year in succession. A dynamic speaker, he won the Cape Peninsula Schools debating competition in 1967 and later at University, the S.A. Universities Best Speakers Debate. He was expelled from Rhodes for participating in a sit-in after the banning of Basil Moore, a former U.C.M. official.

Chris attended Bishops in Cape Town and subsequently studied at U.C.T. for three years. In 1970, he moved up to the Transvaal serving a term as Assistant Transvaal Regional Director. The same year, he was elected to the position of Transvaal Regional Director.

In 1971, he served a jail sentence of 10 days for being in Soweto illegally. He and his two friends had taken a dog to Mrs Mandele, who had appealed for protection from night marauders.

RICK TURNER BANNED NO PASSPORT

Is thirty one years of age. Rick obtained a B.A. Hons. from the University of Cape Town and then studied for a doctorate on Sartre at the Sorbonne. He has been a senior lecturer in Political Science at UND since 1970. and has published quite widely including "The Eye of the Needle", a critical analysis of the social and economic structure of S.A.'s capitalistic society. Dr. Turner was elected to the NUSAS Advisory Panel in 1971 - the advisory panel acts as a group of persons at each campus centre who make themselves available to the National Union should it require advice on any issue. Advice is therefore given at the request of the National Union - these positions are not used in order to manipulate the National Union.
