MINUTES OF THE 54TH NUSAS CONGRESS HELD AT THE UNIVERSITY OF THE WITWATERSRAND 29TH NOVEMBER - 2ND DECEMBER, 1976

Mr. de Villiers assembled the delegates, welcomed them and informed those present that NSA was not quorate, as the Durban delegation had not yet arrived. Nevetheless Mr. de Villiers delivered an unofficial opening speech, saying that while NUSAS had seen a difficult year it had survived well and was once again a viable student organization. Accommodation, the agenda and general administrative arrangements were discussed. Mr. de Villiers also mentioned that as head office no longer employed several full-time office bearers, Mr. Haysom and he intended to share the chair.

"Delete the clause beginning 'Resolves 2'." He claimed that while the secretary had recorded as Amendment C "Delete all words after" whithin our African context'", Mr. de Villiers had given the impression in his proposal speech that he intended Amendment C to read "Delete the clause beginning 'Resolves 2'. Mr. Sarbutt further argued that whether or not this had been the intention of Mr. de Villiers, Mr. Haysom (the chairman) had put the Amendment to the floor in the form "Delete the clause beginning 'Resolves 2'." NSA had therefore been under the impression when adopting Resolution 56/77 that the clauses beginning "Further resolves" and "Therefore" remained included in the motion. No motion of review on Resolution 56/77 was proposed and hence the situation remains unclear. "As secretary at the time I have recorded Resolution 56/77 as I understood it to read However I recommend that the above dispute be cleared up either by Student Assembly in council or by National Council" - Pete Brits.

i) That the National Union and NUSED having note of the Constitution of each body do declare these to be compatible /and and complementary, as both organisations have as primary objectives the promotion of the educational and general interests of students;

- ii) That the National Union and NUSED agree that the basis of the agreement between the two organisations shall be a joint upholding of the principle and aims contained in both Constitutions with special reference to the Declaration of Human Rights and the preamble of the National Union's Consitution;
- iii) That NUSED and the National Union do agree that the administrative affairs of NUSED should be conducted by the National Union's Head Office and that the financial records and books of NUSED shall be incorporated in those of the National Union;
- iv) That it is agreed that, notwithstanding anything contained in this article of association, both the National Union and NUSED shall retain autonomy as separate organisations, shall be separate legal persona and shall have no legal responsibility for the affairs of each other;
- v) The National Union and NUSED do agree that each organisation shall enjoy representation at the annual meeting of the other but that neither organisation shall exercise any votes at such meeting;
- vi) This article of association shall only remain in force while mutually agreed upon by NUSED and the National Union and either party may at any time withdraw from the association by a simple majority decision of its annual meeting.
